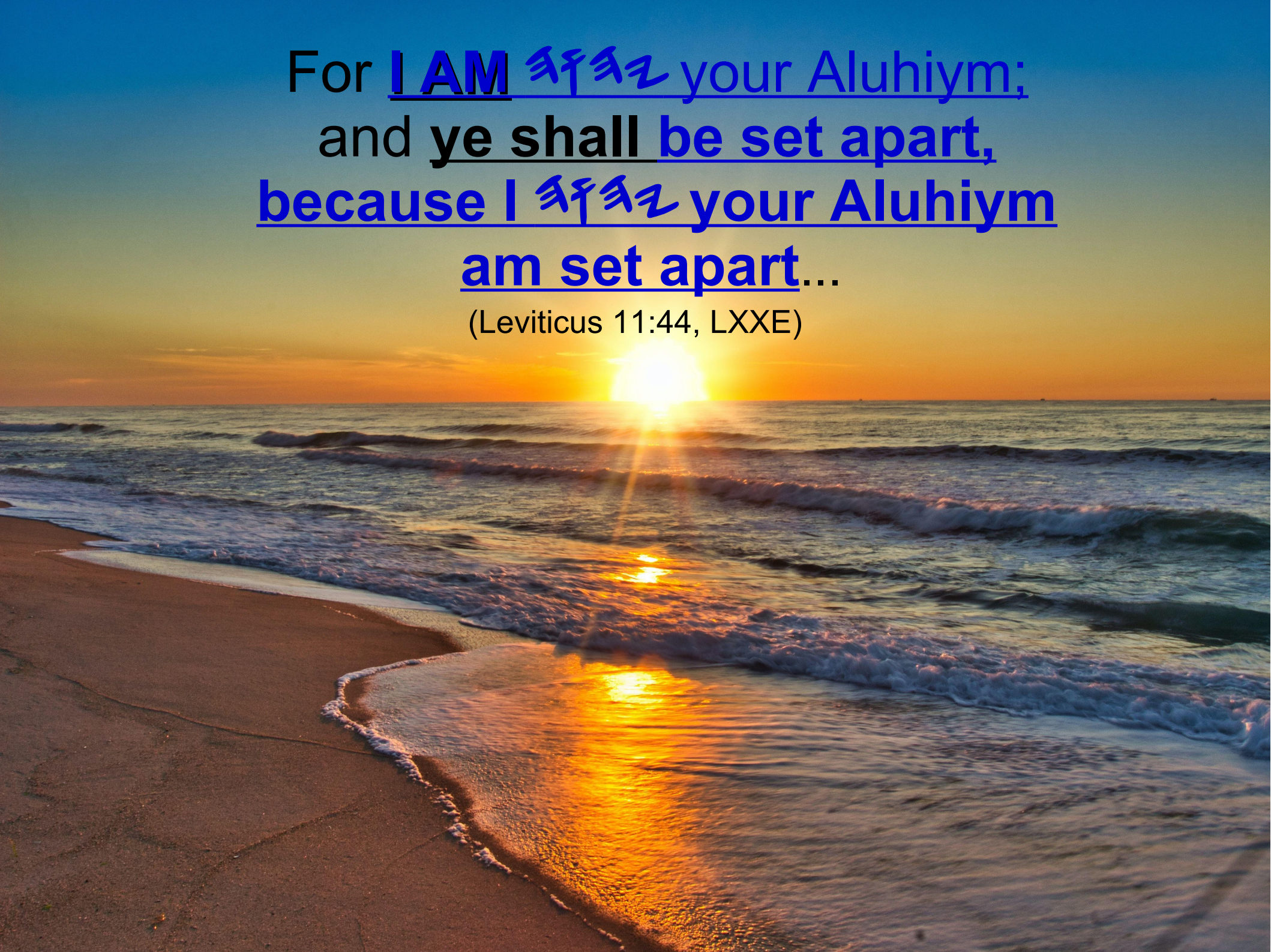

At The Mountain of אֶלְעִז

- And Moses was feeding the flock of Jethro... and he brought the sheep...and came to the mount of Horeb. And an angel of אֶלְעִז appeared unto him in **flaming fire out of the bush**: and he sees that **the bush burns with fire – but the bush was not consumed**. (Exodus 3:1-2, LXXE)



I AM

... אֱלֹהִים called him out of the bush, saying, MOSES... **I AM** (ἐγώ εἰμι) Aluhiym of thy father, the Aluhiym of Abraham, and the Aluhiym of Isaac, and the Aluhiym of Jacob... (Exodus 3:4/6, LXXE)

- I - egō (G1473, ἐγώ), I
- AM -eimi (G1510, εἰμι), to exist, am

And Moses said... they will ask me, What is His name? What shall I say to them? And Aluhiym spoke to Moses, saying, **I AM** (ἐγώ εἰμι) **THE BEING**... (Exodus 3:13-14, LXXE)

- I AM (H1961, אהיה), (I will) to exist, be
- The (G3588, ὁ), definite article: the, one, he
- BEING (G5607, ὄν), present participle of G1510: being, be, exists



I AM – The Same ONE

- And אֱלֹהִים spoke all these words, saying, **I AM** (ἐγὼ εἰμι) אֱלֹהִים thy Aluhiym, who brought thee out of the land of Egypt, out of the house of bondage. Thou shalt have no other gods beside Me. (Exodus 20:1-3, LXXE)
- Then said the Jews unto Him, Thou art not yet fifty years old, and hast thou seen Abraham? אֱלֹהִים said unto them, **VERILY, I say unto you, Before Abraham was, I AM** (ἐγὼ εἰμί). (John 8:57-58)



Be Set Apart in All Things

- But as He which hath called you is set apart, so be ye set apart in all manner of conversation; Because it is written: “Be set apart, for I am set apart.” (1 Peter 1:15-16)
 - “conversation” - anastrophē (G391, ἀναστροφῆ), defined as manner of life, conduct, behavior, deportment
- For **I AM** (ἐγὼ εἰμι) אָפְאָז your Aluhiym; and ye shall be set apart, because I אָפְאָז your Aluhiym am set apart... For **I AM** (ἐγὼ εἰμι) אָפְאָז who brought you up out of the land of Egypt to be your Aluhiym: and ye shall be set apart, for I אָפְאָז am set apart... To distinguish between the unclean and the clean... between those that ...should be eaten, and those that... should not be eaten. (Leviticus 11:44-45/47, LXXE)
 - unclean (H2931, אָמֵס), from H2930, defiled, polluted, unclean
 - (H2930, אָמֵס), defile (self), pollute (self), be (make, make self, pronounce) unclean
 - unclean (G169, ἀκαθαρτων), foul, unclean, impure (morally or demonic)

Be Set Apart in All Things

- And אִף־אֵז spoke... these ye shall not eat... the swine... is unclean to you... all things which have not fins or scales in the water... they shall be abominations to you. Ye shall not eat of their flesh... winged creatures that creep, which go upon four feet, are abominations to you... And by these ye shall be defiled... (Leviticus 11:1/4/7/10-11/20/24, LXXE)
- For **LAM** (ἐγὼ εἰμι) אִף־אֵז who brought you up out of the land of Egypt to be your Aluhiym: and ye shall be set apart, for I אִף־אֵז am set apart. This is the law concerning beasts and birds and every living creature moving in the water, and every living creature creeping on the earth: To distinguish between the unclean and the clean; and between those that bring forth alive, such as should be eaten, and those that bring forth alive, such as should not be eaten. (Leviticus 11:45-47, LXXE)
- ...be set apart yourselves also in all behavior; (1 Peter 1:15, NASB)

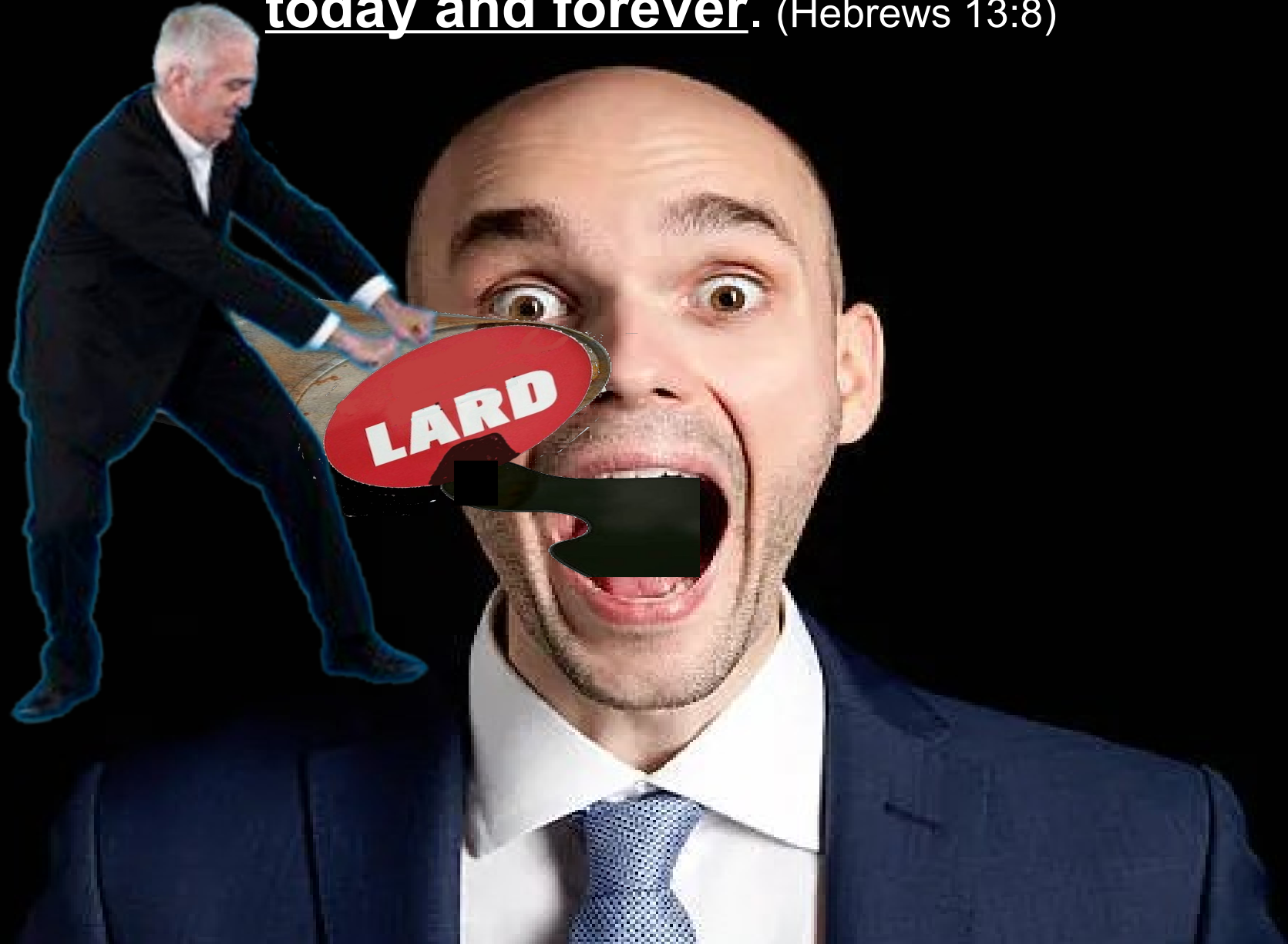


You Are The Temple Now

- ...for **ye are the temple of the living Aluhiym**; as Aluhiym hath said, **I will dwell in them**, and **walk in them**; and **I will be their Aluhiym**, and **they shall be My people**. Wherefore **come out from among them**, and **be ye separate**, saith אֱלֹהִים, and **touch not the unclean thing**; and **I will receive you**, And **will be a Father unto you**, and **ye shall be My sons and daughters**, saith אֱלֹהִים Almighty. (2 Corinthians 6:16-18, quoting **Ezekiel 37:26-27**, **Leviticus 26:12**, **Isaiah 52:11**, **Ezekiel 20:41**, **2 Samuel 7:14**)
 - **unclean** - (G169, ακαθαρτων), Same word used for every single instance of "**unclean**" in Leviticus 11 - LXX)

Scriptures Twisted Into Destruction

- ...even as our beloved brother **Paul** also according to the wisdom given unto him hath written unto you; As also **in all his epistles**, speaking in them of these things; in which are **some things hard to be understood, which they that are unlearned and unstable wrest, as they do also the other scriptures, unto their own destruction.** (2 Peter 3:15-16)

You Are The Temple

Don't Defile The Temple

- Know ye not that ye are the temple of Aluhiym, and that the Spirit of Aluhiym dwelleth in you? If any man defile the temple of Aluhiym, him shall Aluhiym destroy; for the temple of Aluhiym is set apart, which temple ye are. (1 Corinthians 3:16-17)
 - defile (G5251, φθείρει), to shrivel or wither, ruin, corrupt (self), defile, destroy
- And whatever man that shall be defiled and shall not purify himself, that soul shall be cut off from the midst of the congregation, because he hath defiled the set apart things of אֲפֹרֹת, , because the water of sprinkling has not been sprinkled upon him; he is unclean. (Numbers 19:20, LXXE)

Know ye not that **ye are the temple of Aluhiym**, and that **the Spirit of Aluhiym dwelleth in you?** **If any man defile the temple of Aluhiym** **him shall Aluhiym destroy;** for **the temple of Aluhiym is set apart, which temple ye are.** (1 Corinthians 3:16-17)



Your Temple Can Still Be Purified

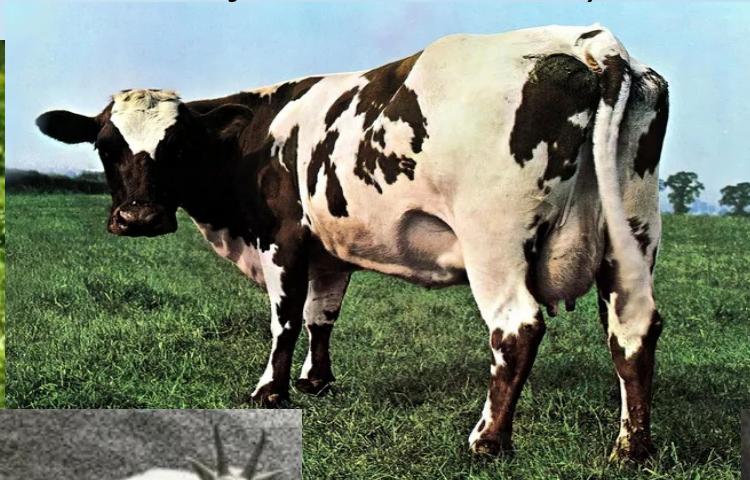
- ...the king sent an old man of Athens to compel the Jews to... not to live after the laws of Aluhiym: And to pollute also the temple in Jerusalem... The altar also was filled with profane things, which the law forbiddeth. (2 Maccabees 6:1-2/5)
- Then said Judas and his brethren, Behold, our enemies are discomfited: let us go up to cleanse and dedicate the sanctuary. And when they saw the sanctuary desolate, and the altar profaned, and the gates burned up... They rent their clothes, and made great lamentation, and cast ashes upon their heads, And fell down flat to the ground upon their faces, and blew an alarm with the trumpets, and cried toward heaven. Then Judas appointed certain men to fight against those that were in the fortress, until he had cleansed the sanctuary... and built a new altar according to the former; (1 Maccabees 4:36/38-41/47)

Remove Filth Towards Sanctification

Clean Animals

- Speak to the children of Israel, saying, These are the animals which you may eat among all the animals that are on the earth: Among the animals, whatever divides the hoof, having cloven hooves **and** chewing the cud - that you may eat. (Leviticus 11:2-3 - NKJV)
- Ye shall not eat any **abominable** thing. These [are] the beasts which ye shall eat; the calf of the herd, and lamb of the sheep, and kid of the goats; the stag, and doe, and pygarg, and wild goat, and camelopard. (Deuteronomy 14:3-5, LXXE)





Pigs... Unclean



- And the swine, because this [animal] divides the hoof, and makes claws of the hoof, and it does not chew the cud, is unclean to you. Ye shall not eat of their flesh, and ye shall not touch their carcasses; these are unclean to you.

(Leviticus 11:78, LXXE)

- And as for the swine, because he divides the hoof, and makes claws of the hoof, yet he chews not the cud, he is unclean to you; ye shall not eat of their flesh, ye shall not touch their dead bodies. (Deuteronomy 14:8, LXXE)

Neither Fins Nor Scales... **Unclean**

- And all things which have not fins or scales in the water... and of every soul living in the water, are an **abomination**; and they shall be **abominations** to you. (Leviticus 11:10, LXXE)



Carrion Birds... Unclean

- And these are the things which ye shall abhor of birds, and they **shall not be eaten**, they are an **abomination**: the eagle and the ossifrage, and the sea-eagle. And the vulture, and the kite, and the like to it; and the sparrow, and the owl, and the sea-mew, and the like to it: and every raven, and the birds like it, and the hawk and his like, and the night-raven and the cormorant and the stork, and the red-bill, and the pelican, and swan, and the heron, and the lapwing, and the like to it, and the hoopoe and the bat. And all winged creatures that creep, which go upon four feet, are **abominations** to you. (Leviticus 11:13-20, LXXE)





Don't Bow to The Stomach God

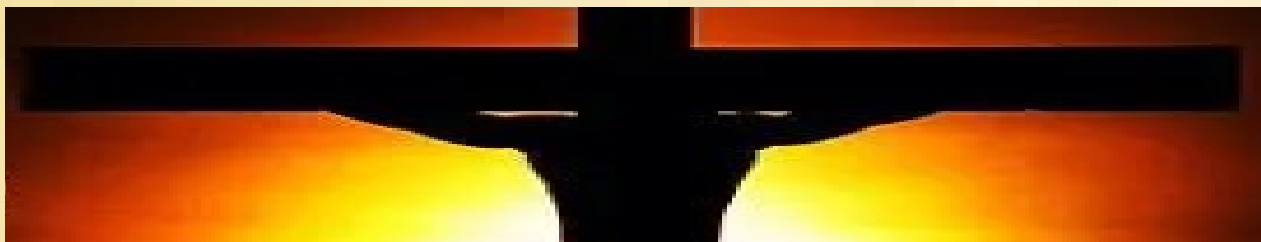


King Stomach

- I press toward the mark for the prize of the high calling of Aluhiym in Messiah @wfa2 ... Brethren, be followers together of me, and mark them which walk so as ye have us for an ensample. (For many walk, of whom I have told you often, and now tell you even weeping, that they are the enemies of the cross of Messiah: Whose end is destruction, whose god is their belly, and whose glory is in their shame, who mind earthly things). (Philippians 3:14/17-19)
 - belly (G2836, κοιλία), a cavity, i.e. (especially) the abdomen; by implication, the matrix; figuratively, the heart:—belly, womb
 - ...**Jonah was three days and three nights in the whale's belly** (G2836)... (Matthew 12:40)

The Disobedient People...

- I said, **Behold, I am**, to a nation, who called not on My name. **I have stretched forth My hands all day** to a **disobedient and gainsaying people, to them that walked in a way that was not good, but after their sins.** This is the people that provokes Me continually in My presence... **they that eat swine's flesh,** and **the broth of sacrifices: all their vessels are defiled:** who say, Depart from me, draw not nigh to me, for I am pure. This is the smoke of My wrath, a fire, burns with it **continually.** Behold, it is written before Me: I will not be silent until I have recompensed into their bosom, their sins and of their fathers, saith אף אף... **I will deliver you up to the sword, ye shall all fall by slaughter:** for I called you, and ye hearkened not; I spoke, and ye refused to hear; and **ye did evil in My sight,** and **chose the things wherein I delighted not.** (Isaiah 65:1-6/12-13, LXXE)



Many Don't Listen To His Words

- So long too as they did these things to Me: **they defiled My sanctuary**, and profaned My Sabbaths. (Ezekiel 23:38, LXXE)
- Her prophets are light scornful men: her priests **profane the set apart things**, and **sinfully transgress the law**. (Zephaniah 3:4, LXXE)
- Therefore, as I live, saith אף אעז; surely, because thou hast **defiled My set apart things with all thine abominations**, I also will reject thee; Mine eye shall not spare, and I will have no mercy. (Ezekiel 5:11, LXXE)
- **What?** know ye not that **your body is the temple of the Set Apart Spirit** which is in you, which ye have of Aluhiym, and **ye are not your own?** For ye are bought with a price: therefore glorify Aluhiym in your body, and in your spirit, which are Aluhiym's. (1 Corinthians 6:19-20)

Judgement For The Unclean

- For, behold, יהוה will come as fire, and His chariots as a storm, to render His vengeance with wrath, and His rebuke with a flame of fire. For with the fire of יהוה all the earth shall be judged, and all flesh with His sword: many shall be slain by יהוה. They that sanctify themselves and purify themselves in the gardens, eating swine's flesh in the porches, and the abomination, and the mouse, shall be consumed together, saith יהוה. (Isaiah 66:15-17, LXXE)
- For I am יהוה your Aluhiym, and I am not changed (Malachi 3:6, LXXE)



Clean Eating For The Kingdom of Priests

- ...these are the chambers of the sanctuary, wherein the priests the sons of Zadok, who draw nigh to אַף אֵל shall eat the most set apart things: and there shall they lay the most set apart things... because the place is set apart. (Ezekiel 42:13, LXXE)
 - And ye shall be to Me a royal priesthood, and a set apart nation... (Exodus 19:6, LXXE)
 - I beseech you therefore, brethren, by the mercies of Aluhiym, that ye present your bodies a living sacrifice, set apart, acceptable unto Aluhiym, which is your reasonable service. (Romans 12:1)
 - And hath made us kings and priests unto Aluhiym and His Father (Revelation 1:6)



Sanctify Your Temple

- Furthermore then we beseech you, brethren, and exhort you by the Adon אֱלֹהֵינוּ, that as ye have received of us how ye ought to walk and to please Aluhiym, so ye would abound more and more. For ye know what commandments we gave you by the Adon אֱלֹהֵינוּ. For this is the will of Aluhiym, even your sanctification... That every one of you should know how to possess his vessel in sanctification and honour... For Aluhiym hath not called us unto uncleanness, but unto sanctification. (1 Thessalonians 4:1-4/7)
- ...behold, the kingdom of Aluhiym is within you. (Luke 17:21)
- Wherefore come out from among them, and be ye separate, saith אֱלֹהֵינוּ, and touch not the unclean thing; and I will receive you, And will be a Father unto you, and ye shall be My sons and daughters, saith אֱלֹהֵינוּ Almighty. (2 Corinthians 6:17-18)



Unclean

The Way

- There shall be there a pure way, and it shall be called a set apart way; and there shall not pass by there any unclean person, neither shall there be there an unclean way; but the dispersed shall walk on it, and they shall not go astray. (Isaiah 35:8, LXXE)
 - dispersed (G1289, διεσπαρμένοι), to sow throughout, distribute in foreign lands: scatter abroad
- @ωϕαζ saith unto him, **I AM** (*Ἐγώ εἰμι*) **the way, the truth, and the life: no man cometh unto the Father, but by Me.** (John 14:6)
- ...**narrow is the way, which leadeth unto life, and few there be that find it.** (Matthew 7:14)
 - This then is the way of light, if anyone desiring to travel on the way to his appointed place would be zealous in his works...**thou shalt hate everything that is not pleasing to Aluhiym**;...**thou shalt never forsake the commandments of αϕαζ.** (Barnabas 19:1-2)

satan's Targets

- satan works to infiltrate, mix, hide, deceive, desecrate, and destroy anything that אף אף אף blesses or sanctifies:
 - His Son (Genesis 12:3; Psalm 118:26; Hosea 11:1; Hebrews 1:3)
 - His Name (Psalm 72:19; Psalm 113:2)

Wrath Falls On The Unclean

- Mortify therefore your members which are upon the earth; fornication, **uncleanness**, inordinate affection, evil concupiscence, and **covetousness, which is idolatry**: For which things' sake the wrath of Aluhiym cometh on the children of disobedience: In the which ye also walked some time, when ye lived in them. (Colossians 3:5-7)
 - ...**Go your ways, and pour out the vials of the wrath of Aluhiym upon the earth.** (Revelation 16:1)



Wrath Falls On The Unclean

- The fire is gone forth from His wrath, and hath consumed the foundations of the earth, and the sinners, like the straw that is kindled. Woe to them that sin, and keep not My commandments! saith אֱלֹהִים. I will not spare them: go your way, ye children, from the power, defile not My sanctuary. For אֱלֹהִים knoweth all them that sin against Him, and therefore delivereth He them unto death and destruction. For now are the plagues come upon the whole earth and ye shall remain in them: for Aluhiym shall not deliver you, because ye have sinned against Him. (2 Esdras 15:23-27)



No Unclean Shall Enter

- For this ye know, that no whoremonger, nor unclean person, nor covetous man, who is an idolater, hath any inheritance in the kingdom of Messiah and of Aluhiym. (Ephesians 5:5)
 - “unclean” - akathartos (G169, ἀκαθάρτου), impure, foul, unclean (morally i.e. Levitical law, or demonic)
 - *(yes, the same word used 22 times in Leviticus 11 LXXE)*
- And I saw a new heaven and a new earth: for the first heaven and the first earth were passed away... And He that sat upon the throne said, **Behold, I make all things new**... And the nations of them which are saved shall walk in the light of it: and the kings of the earth do bring their glory and honour into it... And there shall in no wise enter into it any thing that defileth, neither whatsoever worketh abomination, or maketh a lie: but they which are written in the Lamb's book of life. (Revelation 21:1/5/24/27)

Unclean And Food Preparation

- And on whatsoever one of their dead bodies shall fall it shall be unclean; whatever wooden vessel, or garment, or skin, or sack it may be, every vessel in which work should be done, shall be dipped in water, and shall be unclean till evening; and [then] it shall be clean. And every earthen vessel into which one of these things shall fall, whatsoever is inside it, shall be unclean, and it shall be broken. And all food that is eaten, on which water shall come [from such a vessel], shall be unclean; and every beverage which is drunk in any [such] vessel, shall be unclean. And every thing on which there shall fall of their dead bodies shall be unclean; ovens and stands for jars shall be broken down: these are unclean, and they shall be unclean to you. (Leviticus 11:32-35, LXXE)



The Fat

- If his oblation be a sacrifice of peace offering, if he offer it of the herd...of the flock... And if his offering be a goat...And he shall offer thereof his offering, even an offering made by fire unto אֵף אֵז; the **fat** that covereth the inwards, and all the fat that is upon the inwards, And the two kidneys, and the **fat** that is upon them, which is by the flanks, and the caul above the liver, with the kidneys, **it shall he take away.** And the priest shall burn them upon the altar: it is the food of the offering made by fire for a sweet savour: all the fat is אֵף אֵז's. **It shall be a perpetual statute for your generations throughout all your dwellings,** that ye eat neither **fat** nor blood. (Leviticus 3:1/6/12/14-17)

- **Suet** is hard **fat** found in the neighborhood of the kidneys and around some other organs from cows, sheep, goats, or pigs.

Animal Fats

- Animal fats (tallow, suet, lard)
 - **Suet** is hard fat found in the neighborhood of the kidneys and around some other organs from cows, sheep, goats, or pigs
 - **Tallow** is a euphemism for body fat from cows, sheep and goats. Tallow starts with the extraction of suet from a carcass.
 - Tallow and other animal fats are processed into fatty acids and used for cosmetics, pharmaceuticals, personal care products, inks, paints, coatings, adhesives, lubricants, and soaps. Tallow is also used in industrial animal feed and in bird food
 - **Lard** is body fat from pigs. There is no guarantee that a manufacturer never mislabels pig fat as tallow.



Unclean Animal Fatty Acids

- These fatty acids are used in soaps, stable creams, lotions, ointments, deodorants/antiperspirants, foundation creams, hand lotions, cosmetics, hair straightening products, shaving creams, some foods (including margarine, shortening and other baking ingredients), a softener in chewing gum base, and suppositories
- Frequently obtained from a slaughterhouse by-product known as tallow or animal fat.
 - **Stearic Acid** - a wax-like fatty acid, frequently sourced from tallow
 - **Myristic Acid** - a minor component of many other animal fats
 - **Palmitoleic Acid** - sourced from animal tallow
 - **Linoleic Acid** - sourced from animal tallow
 - **Oleic Acid** – an omega-9 fatty acid found in various animal sources
 - **Palmitic Acid** - one of the most common fatty acids found in animals
 - **Lauric Acid** – found in cow's milk, and goat's milk (likely clean)

Hidden Unclean Animal Fat

- **Glycerides (mono/di/and tri)** tend to be derived from animal fats, and are used frequently by the food industry.
 - Mostly used and labeled as “Mono and diglycerides”
- **Glycerin** is used in soaps, toothpastes, mouthwashes, chewing gum, ointments, pharmaceutical formulations, cough syrups, elixirs and expectorants. It is also used extensively in cosmetics, including in perfumes and lotions, skin care products, shaving cream, and hair care products. It even makes its way into inks, glues and plastics, lubricants, anti-freeze, a thickening agent in liqueurs, and brake fluid.
- **Glycerin(e) or Glycerol (labeled E422 in food)** is a byproduct of soap manufacturing, and can be either synthetic, or derived from plants (usually soybeans) or animals (usually tallow).
- **Polyglycerol** (a derivative) can be found in some shortening and margarine.

Glycerin/ Glycerol

- Glycerol is generally obtained from animal (or plant) sources where it occurs in triglycerides. Typical plant sources include soybeans or palm. Animal-derived tallow is another source.
 - Triglycerides are the main constituents of body fat in humans and other vertebrates
- The EU directive 2003/30/EC set a requirement that 5.75% of petroleum fuels were to be replaced with biofuel sources across all member states by 2010. It was projected in 2006 that by 2020, production would be six times more than demand, creating an excess of glycerol as a byproduct of biofuel production. Because of the large-scale production of biodiesel from fats, where glycerol is a waste product, the market for glycerol is depressed. Thus, synthetic processes are not economical.
 - Biodiesel is a renewable biofuel, a form of diesel fuel, derived from biological sources like vegetable oils, animal fats, or recycled greases, and consisting of long-chain fatty acid esters. It is typically made from fats.

Hidden Animal Fat and Unclean

- **Neither repented they of their** murders, nor of their **sorceries**, nor of their fornication, nor of their thefts. (Revelation 9:21)
 - Sorceries – pharmakeia (G5331, φαρμακειῶν), medication ("pharmacy"), i.e. (by extension) magic (literally or figuratively): sorcery, witchcraft.
- Magnesium stearate – Uses **Stearic Acid**
 - Used in most over the counter medications in pill form (pharmakia)

Hidden Unclean Animal Fat Soaps and Shampoos

- And I heard another voice from heaven, saying, **Come out of her, My people, that ye be not partakers of her sins, and that ye receive not of her plagues.** (Revelation 18:4)
 - **But you should always that assume soap contains animal-based ingredients** unless the label says otherwise... **Ivory Soap**, for instance, carries the phrase “99.44% pure” on its label. Yet the stuff **is largely made from rendered animal fat obtained from slaughterhouses**. Soap made from animal fat often has **“sodium tallowate”** listed on its label... *

Hidden Unclean Animal Fat Beauty Products

- Beauty companies tend to spend a fortune on fancy packaging while cutting corners on their products' actual ingredients. Viscous fats and proteins are the primary components of most beauty products. And there's no cheaper source of these substances than a slaughterhouse. That means that most beauty products, unless they are deliberately formulated to be vegan, contain animal ingredients.
- Unlike food, you won't be able to determine an item's vegan status by reading the ingredient panel. That's because beauty companies use countless substances that aren't allowed in food. And some of these chemicals can be made from vegan or animal sources. “Natural Flavors”

- Both natural and artificial flavors are synthesized in laboratories, but artificial flavors come from petroleum and other inedible substances, while **“natural flavor” can refer to anything that comes from** a spice, fruit or fruit juice, vegetable or vegetable juice, edible yeast, herb, bark, bud, root, leaf, **meat**, **seafood**, poultry, eggs, dairy products, or anything fermented from those foods, according to Food and Drug Administration spokesperson Deborah Kotz.
- To create a passionfruit-flavored product with actual passionfruit... flavorists would need to consume a quarter of the world’s passionfruit supply... Instead, the flavor team will look for **cheaper sources** that mimic the fruit’s molecular fingerprint... Once she has the base substance, she’ll dilute it with water, **glycerin**, or ethanol... And despite the fact that these flavors are blended in a lab, they’d still be considered natural on a label... according to the CDC.
- The FDA doesn’t require food labels to say what’s in their “natural flavor” unless the ingredients include a common allergen like milk, egg, fish, shellfish, tree nuts, wheat, peanuts, or soy... **For those of us who want to know exactly what’s in our food, well, we’re not going to get clarity any time soon.**

Hidden Unclean Animals and Fat (Frozen Meat Additives)

- ...behind the scenes of food manufacturing, frozen meat is being defrosted, pumped up with water and additives, then re-frozen all over again, and consumers are none the wiser.
- Though this week's news has focused on chicken, the technique of adding water and additives is applied to a vast range of produce... Indeed, almost any low-grade, mass-produced, frozen or processed meat will have been treated this way.
- The controversial process usually begins when the manufacturer acquires his supply of what is called 'trim', usually pieces of boned, frozen meat... His next task is to bulk out the trim by getting it to absorb water and additives (called a brine). The brine consists of water and five main sources (separately or mixed together):
 - transglutaminase, an enzyme that is essentially a natural glue ("meat glue")
 - hydrocolloids, substances that form a gel on contact with water
 - phosphate, which is taken from phosphoric acid and is valued for its ability to make oil adhere to water
 - fibre, made from a source such as wheat, citrus or cellulose (wood)
 - protein powder, which is made by extracting collagen from pigs' skins, chicken stock, or a soy protein that tends to be made from genetically modified crops

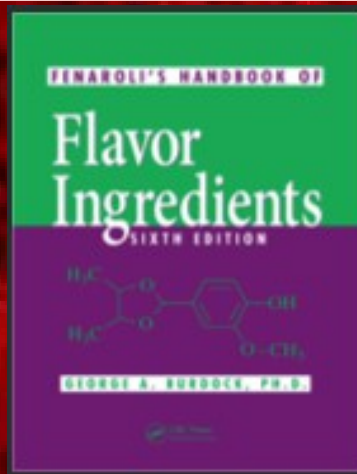

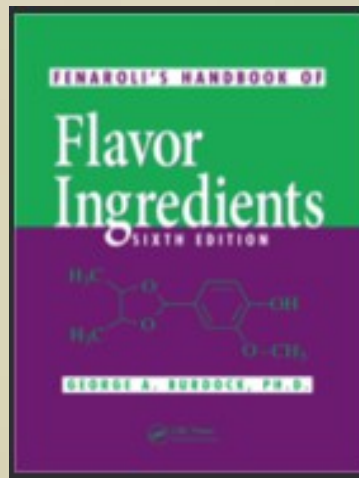

The part used is scent gland secretion from castor sacs (dried and ground). Castoreum has a warm, animal-sweet odor, becoming more pleasant on dilution. Sometimes a birch, tar-like, musky odor is also perceptible.

Derivatives: Dried secretion, tincture, resinoid, absolute. The resinoid is prepared by extraction of the dried, ground pouches using petroleum ether. The absolute is prepared by the alcoholic extraction of the resinoid.

- Castoreum is a beaver castor sac glandular secretion next to its anal canal and mixed with urine to mark territory.

Making RNA vaccines easier to swallow

- But recent vaccine conspiracy theories are casting an air of fear around more mundane things — like cows and lettuce.
- In widespread posts online in recent weeks, misinformation purveyors have spread an erroneous narrative that COVID-19 mRNA vaccines are being quietly added to the food supply, threatening staunch vaccine holdouts.

- I said, But do ye **fear Me, and receive instruction, and ye shall not be cut off** from the face of the land [for] all the vengeance I have brought upon her: **prepare thou**, rise early: **all their produce is spoilt**.
